Willie Mae Rock Camp for Girls is a non-profit music and mentoring program that empowers girls and women through music education, volunteerism, and activities that foster self-respect, leadership skills, creativity, critical thinking, and collaboration. The organization operates a summer day camp, after school programs, and community events in New York City.

Girls summer camp: Provided music education and confidence building activities for 168 girls during two 6-day summer camp sessions. Achieved goals of bringing together girls from diverse communities and encouraging them to explore self expression through music, hone their critical thinking skills, build meaningful alliances with other girls, develop confidence in making healthy choices in their lives, and effect positive change in their communities and in the world. A total of 168 volunteers donated 4,636 hours of service during the summer camp sessions, at an estimated value of \$99,025. Program activities involved donated use of a school facility at an estimated value of \$18,000.

Music Lab: Provided music education and confidence-building activities for 57 girls during weekly after school sessions and community events throughout the school year. Achieved goals of encouraging creativity and collaboration, and laid groundwork for educational and artistic excellence.

Ladies Rock Camp: Provided music education and confidence-building activities for 72 women during two 3-day intensive music education sessions. A total of 39 volunteers donated 948 hours of service during the Ladies Rock Camp sessions, at an estimated value of \$20,249. Program activities involved donated use of a school facility at an estimated value of \$9,000.
